





Dear Mr. Yalung:

This has reference to your company's request of non-coverage under Department Order No. 174, Series of 2017.

A perusal of the Amended Articles of Incorporation showed that the primary purpose of Tork Philippines Inc. is to engage in the business of general construction and other allied businesses including the constructing, enlarging, repairing, removing, developing, or otherwise engaging in any work upon buildings, roads, highways, manufacturing plants, bridges, airfields, piers, docks, mines, shafts, waterworks, railroads, railways structures, all iron, steel, wood, masonry and earth construction and to make, execute, bid for and take or receive any contracts or assignment of contracts therefore or in relation thereto, or connected therewith, and to manufacture and furnish building materials and supplies connected therewith, and doing or any and all other business and contracting incidential thereto or connected therewith, and the doing and performing of any and all acts and things necessary, proper or convenient for and incidental to the furtherance and or implementation of the purposes therein mentioned.

DOLE Department Circular No. 01, Series of 2017 entitled "Clarifying the Applicability of Department Order No. 174, Series of 2017", states that PCAB registered contractors are not required to register under DO 174-17. Only those which are engaged in other contracting arrangements in addition to, or other than construction activities shall be required to register under Department Order No. 174, Series of 2017.

Accordingly, on the condition that your company will not engage in the contracting activities outside the construction industry, this Office is of the opinion that your company is not required to register under DO 174.

Be reminded that this opinion is based on the facts presented and without prejudice to the findings of the appropriate DOLE Regional Office based on the result of inspection conducted pursuant to Department Order No. 183, Series of 2017. Any undisclosed information material to the issue/s being raised may bring about a different opinion. This is strictly advisory and may not be invoked in any courts of law or administrative body.
